

# LETTER FROM THE CHIEF EXECUTIVE PAUL TILLEY

Hello and welcome to the latest issue of our £notes newsletter.

Little did I think that I would be writing a second annual report whilst the UK, and most of the world, is still in the midst of the Covid-19 pandemic. I cannot recollect such a disruptive period as the last twelve months but there is light at the end of the tunnel, particularly in the UK.

It is testament to colleagues' tenacity, commitment and perseverance, and our contingency planning, that the Society has very much remained "open for business as permitted by the government's guidelines, but with a few changes made along the way. Many colleagues have been, and continue to be, successfully and securely working from home to continue to offer you the service you require from us, with others working from Covid-19 secure branches and offices, albeit with a number of modifications for everyone's safety. As a member of the Society your flexibility and understanding has been most welcome during these challenging times. Protecting the physical and mental health of colleagues and members remains a key objective for the Society as a caring and considerate employer and business. The last year has really been about us all pulling together as a team so I'd like to record my sincere personal thanks to everyone.

Sadly, the Annual General Meeting (AGM) will be held virtually again this year – please see Page 4 for further details of how you can still be involved.

Against this back drop, the Society remains financially robust, has performed well in the last year and did not need to access any government financial support. It is a testament to our resilience and sustainability that we have been recruiting for further colleagues as the business continues to expand.

The Society is owned by you, our members, and your best interests are at the heart of everything we do. Offering competitive products allied to a first class service is a core strategic aim. Additionally, we strive to provide easy to understand processes to make your engagement with us fulfilling.

Providing a safe and secure home for savers' money remains an integral aspect of our strategy.

The last twelve months has seen the Society continue to grow the business, with increasing balances held by personal savers and owed by borrowers, with both metrics ahead of budget.

Pleasingly, total mortgage balances are at an all-time record of over £115m with new lending increasing by almost 10% compared to the preceding business year, despite the property market being closed for a period of time.





The pipeline of loan commitments for the forthcoming year is healthy and provides for optimism for continued mortgage asset growth but there remains a degree of uncertainty over future credit conditions.

The difference between average saver and average mortgage interest rates has deliberately fallen as we try to protect both sets of members, as far as it is financially sensible to do so. The Society remains in a very sound and stable financial position, as evidenced by a modest increase in profit year-on-year and the cost ratio falling.

Feedback from members is vital for the wellbeing of esbs and to assist us with developing our proposition. For each of the last two years 97% of new members stated they would recommend the Society to others. In addition, the Society has won one national award during the last 12 months in the lending arena.



These outcomes clearly demonstrate that members retain confidence in the Society and its product and service offering. I am passionate that we must continually seek ways to improve on the products and service we provide to members.

The work undertaken in the community and charitable activities play an important part in retaining our heritage and culture. Given the pandemic restrictions, there was reduced in-person activity but was switched, where possible, to other delivery mechanisms. Please see Page 2 on Leicestershire Cares as a prime example of the work we do, sometimes collaboratively, to maximise benefit.

The economic path forward is uncertain due to the effects of the pandemic. Unemployment and house price movement predictions are far from clear. However, the Society is financially and operationally well positioned to continue to grow and develop in a sensible and controlled manner, within defined risk appetites. Continuing to expand our distribution further, both direct to market and via the intermediated area, will help drive this growth aspiration.

The Society is committed to a digitisation strategy but this will be carefully managed so as to provide member benefit in a secure manner. Technological changes around process simplification & improvement, automation and integration will continue to be identified and deployed where needed. Further security enhancements to our customer online offering are planned to be deployed shortly.

Providing customer contact choice remains key – members should be able to decide how they communicate with us.

The Society is currently developing its climate change strategy and already permits borrowing to facilitate improvements to property to increase energy efficiency and reduce the carbon footprint. In addition, the Society has been actively recycling for many years. The Society is looking at measures to see if it can improve its estate energy efficiency.

As I conclude it is worth reflecting that the Society has, so far, successfully navigated its way through the current pandemic and many other turbulent times in its long history, and it will continue to handle whatever difficulties comes its way. We remain here to serve you to the best of our abilities.

## **ACTION HOMELESS UPDATE**


We are proud to be continuing our corporate sponsorship with Action Homeless in 2021.

This year we need to make certain rule changes for the following reasons:

- To allow our Members' meetings to be held electronically and/or in more than one place;
- To better explain how we can adjourn a Members' meeting:
- To better explain the number of Members' who must be present for a Members' meeting to be valid;
- To improve the procedures we must follow to tell you about a Members' meeting if the postal services are not working as they should be; and
- To include within the Rules legal aspects of the Mental Health (Discrimination) Act 2013 that apply to esbs.
